

### Case Summary

- This purchase was initiated from the cardholder's Google Account using a recognized account, mobile device, and credit card.
- While entering the Google Account password before each in-app purchase is the default purchase authentication method turned on in users' settings for the Google Play app, users can turn authentication for purchases off.
- To use Google Pay, users must accept (1) the Google Terms of Service, (2) [these Google Pay/Google Payments Additional Terms of Service](#). The latter clearly states: "Regardless of the transaction security features you select, you assume responsibility for all charges made through your Google Account, including unintended or unauthorized purchases made through Google Pay."
- The Cardholder bought digital content from the Google Play Store (<https://play.google.com>). Digital content includes mobile games, apps, in-app purchases (e.g. virtual currency), and digital media. The order was delivered electronically.
